This year there was reimbursement of children school fee of Rs. 26000 per child for 2 child for 2 yrs. Originally the assessee claimed exemption in those years u/s 80 C out of her other income. Whether the amount received this year is tax-free or not as per BSF guidelines. Pl. suggest.

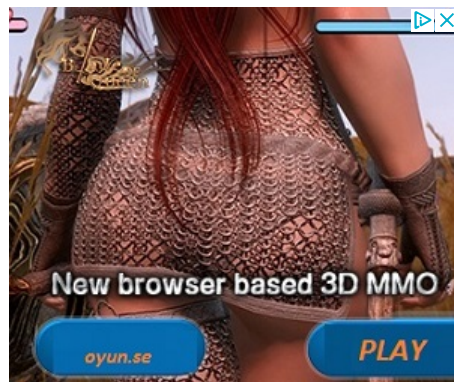
