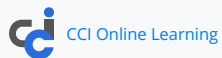
Although I was also hopeful that at least this time the results would be good.

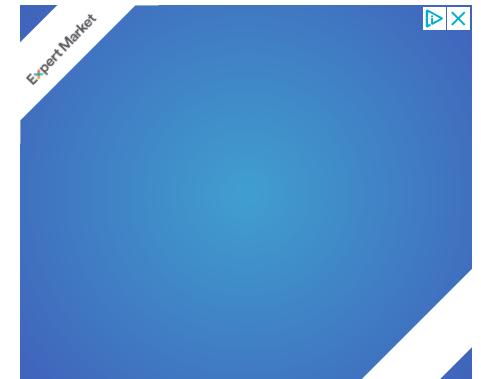
