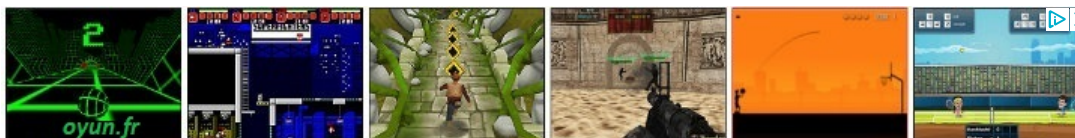

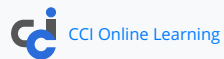
and never loose heart. stay focussed to your goal. Market always respect and in need of hard worker knowledgable people.


