Assessee who has paid service tax of **Rupees One Lac or more including CENVAT Credit** during the preceding year are **required to pay service tax electronically w.e.f. 1st January, 2014**. Earlier this limit was **Rupees Ten Lacs or More**.

Therefore, Service tax liability for the month/quarter ended December-2013 will be subject to above change, where payment is to be made in cash.

CBEC has issued Notification No. 16/2013-ST dated 22-11-2013 in this regard.

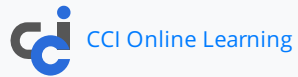

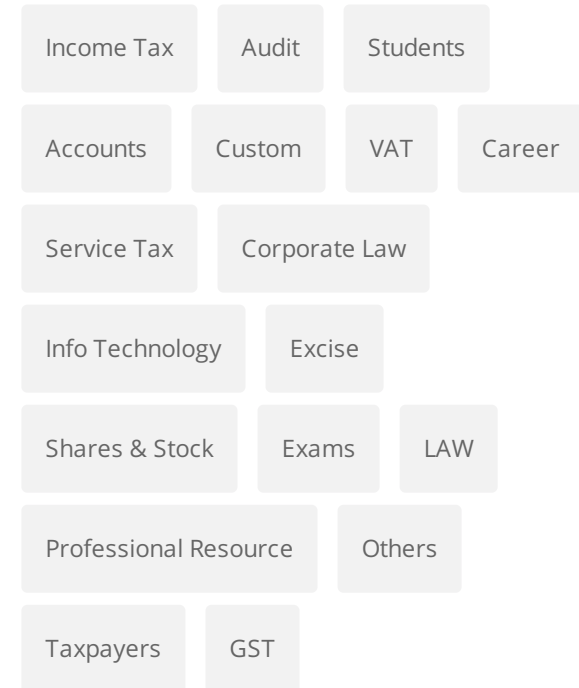

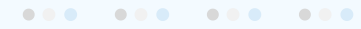
