I think now u got my doubt!!!!



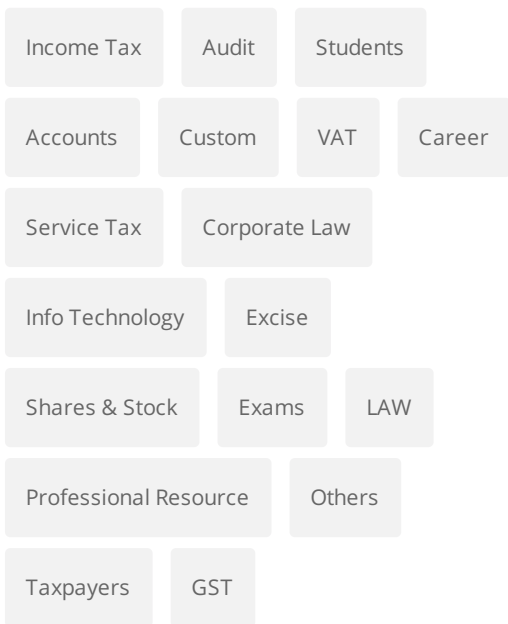
