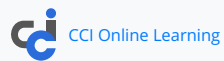

Earlier, the DIN had to be applied offline by sending the documents to DIN Cell, Noida whereby teh aplicant get the Provisional DIN. And after the DIN Cell receive the documents, they approve the DIN. But not the DIN is approved through STP if the application is signed by any Professional i.e. CA/CS/CWA after verifying all the documnets completely.
