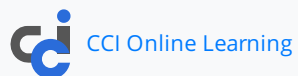

In hands of Political Parties/Electoral Trust:-

Any amount of donation received in Cash above 2000/- shall be Disallowed in their hands. But Upto 2000 cash donation can be accepted by them.

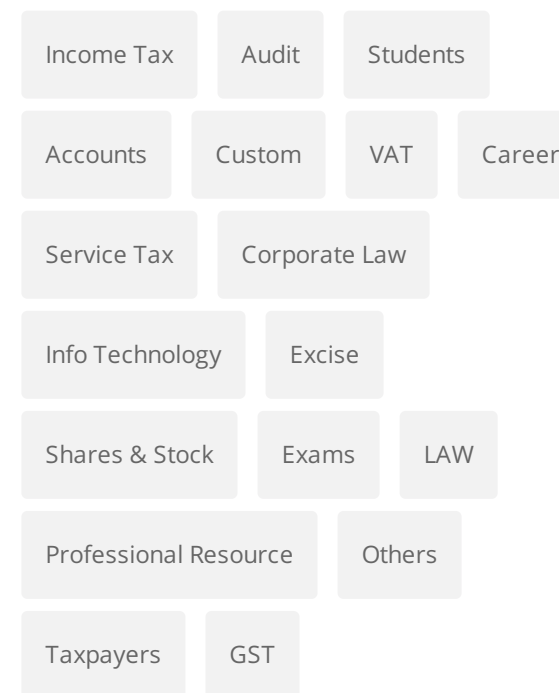

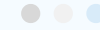

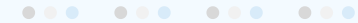
