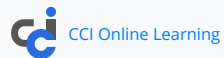

And also if income is below exemption limits then no need to file return you can prove it by showing the form 16

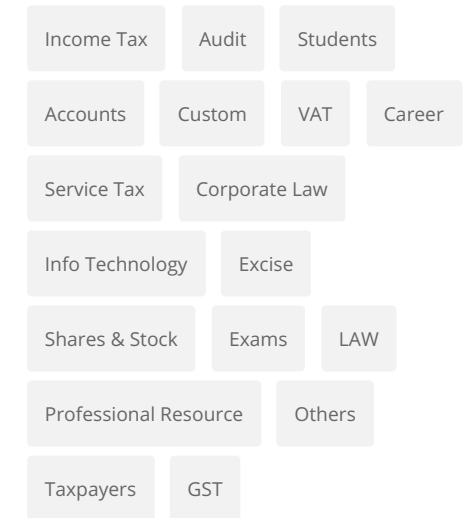
