Have been onto Oracle Apps since I qualified as CA. It seems that from last couple of years, its been irritating and frustratiing the job I do.

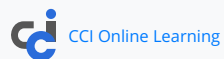

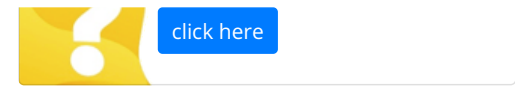
