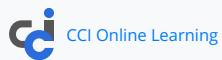

They must be post graduates or completed masters from the Recognized UGC approved University and College.

They must complete the masters in the subject from the University and College with around 55 % marks overall (50% marks in the post-graduation for the Reserved cat. candidates)

The candidates in the Final Year of the masters can also apply for the exam. The **UGC NET** Exam is carried out in the month of June and December every year. You can apply in the Exam in the both Months.

The Exam is to be conducted in the month of December. The Exam dates is announced, and the exam is on 9th to 23 December
