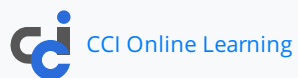

As per Sec. 139(5), an assessee can file the Belated return till 1 year from the end of the relevant assessment year.

so only 2 years return can be filed, i.e, for Ay 2008-09 & AY 2007-08 today 18.6.2008. u could have filed the return for AY 2006-07 on 31.03.2008.

it is provided in section 139 clearly that belated return can be file upto the one year from the relevant assessment year so for assessment year 2007-08 return can be file upto 31/03/2008 with penalty of Rs 5000/- and for assessment year 2008-09 is can be filed . but no return can be file for assessment year 2006-07. This is all about act.
