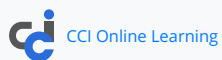

I am a retired bank officer. I retired from bank's service on 31.10.2017, i.e., in the financial year 2017-18, and assessment year 2018-19. At the time of my retirement I received my retirement benefits from the bank, like PF, gratuity etc., the tax was deducted at source by the bank. Thereafter, I also deposited a sum of Rs.45,000 towards advance tax in the month of February, 2018, everything perfect and nothing astray.
