Invoice date 5.11.19

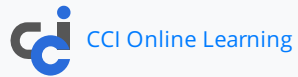
Payment terms: 15 days month end (i.e.30.11.19)

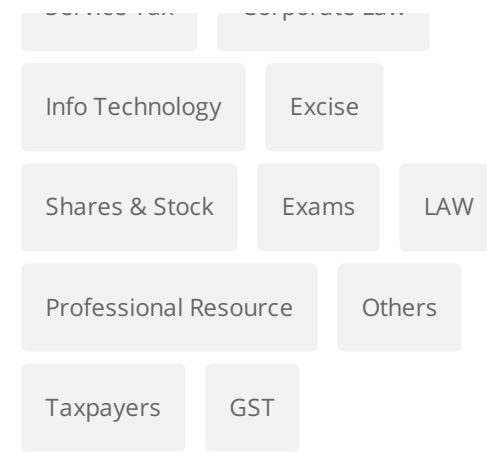

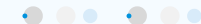
