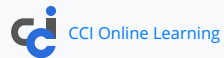

Cancellation of Professional Tax Certificate

- 1) Online login into the account make the cancellation Application
- 2) Take the print out of Acknowledgement
- 3) Submit the following document in department a) Application of cancellation with affix of 5 Rs. court fees stamp
b) Original Professional tax Certificate
c) Original Challan Copy
d) Letter of Authority in favors of person. attending department
- e) Closure proof (bank statement, Previous year financial, Salary Register etc)
- 4) After submitting all the documents department will cancel the certificate in 30 days, you can check the status online.
- 5) Note Till the cancellation done by the department fill the necessary return
