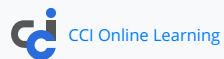

Sir, I'm a Sub-Contractor rendered WorksContract service to Main Contractor. I submitted tax invoice including Service Tax. Main contractor did not pay me Service Tax citing that they have already paid ServiceTax portion to Respective Department as part of complete project under 60% and 40% ratio

Now I have received a Service Tax Notice demanding along with penalty & interest since 2014. I'm not in talking terms with Main Contractor as other dispute in the court. Now what are my option.

In fact, the contractor earlier did not release due amount as per the MSMED act and I approached MSEFC and got the payment cleared by way of settlement without considering Service Tax portion.? The demand with penalty with interest runs into 100Lacs and I can not make payment. Thanks,
