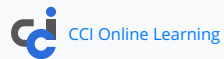

Penalty that is late fee depends upon total income upto 5 lakhs = Rs 1000 and above 5 lakhs = 5000/- (if filed before 31-12-2019)

And after that 5000/- becomes 10000/- upto 31-3-2000.

For late filing of Audit report under 44AB , high penalty is there .

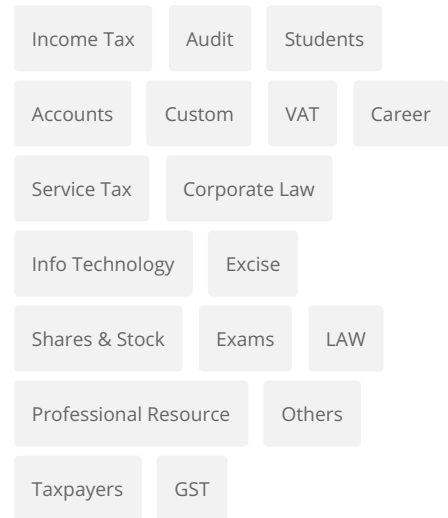
