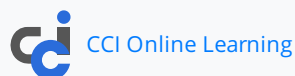

[a] declaration of any dividend; or

[b] distribution of any dividend; or

[c] payment of any dividend,

whichever is earliest.

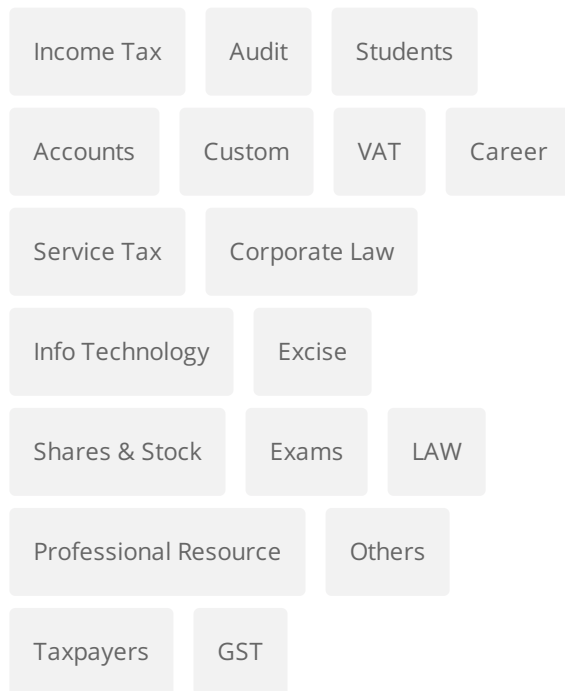

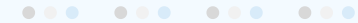
