GST collection drops by 5.29% to 95380 crore in October

The gross GST revenue collected in the month of October, 2019 is **Rs 95,380 crore** of which CGST is **Rs 17,582 crore**, SGST is **Rs 23,674 crore**, IGST is **Rs 46,517 crore** (including **Rs 21,446 crore** collected on imports) and Cess is **Rs 7,607 crore** (including **Rs 774 crore** collected on imports). The total number of GSTR 3B Returns filed for the month of September up to 31st October, 2019 is **73.83 lakh**.

The government has settled **Rs 20,642 crore** to CGST and **Rs 13,971 crore** to SGST from IGST as regular settlement. The total revenue earned by Central Government and the State Governments after regular settlement in the month of October, 2019 is **Rs 38,224 crore** for CGST and **Rs 37,645 crore** for the SGST.

The revenue during October, 2019 is declined by 5.29% in comparison to the revenue during October, 2018. However, during April-October, 2019 vis-à-vis 2018, the domestic component has shown **6.74%** growth while the GST on imports has shown negative growth and the total collection has grown by **3.38%**.
