MCA deactivates non-compliant DINs

Please note that the DINs which have not complied with the requirement of filing DIR-3 KYC have since been marked as 'Deactivated due to non-filing of DIR-3 KYC'. Such DINs are not allowed to be used for filing any eforms on the MCA21 portal. In case the present status of your DIN is 'Deactivated due to non-filing of DIR-3 KYC', you are required to file 'KYC' using eform DIR-3 KYC or DIR-3-KYC-WEB service as applicable with prescribed fee of INR 5000 to re-activate your deactivated DIN.

Please note that the last date for filing DIR-3 KYC for the Financial year 2018-19 has expired on 14th October 2019. The process of deactivating the non-compliant DINs is in progress and will be completed shortly. Please note that the form DIR-3 KYC and web service DIR-3 KYC will not be available for filing during the pendency of this activity. Filing of DIR-3 KYC and DIR-3 KYC WEB can be made after completion of the scheduled activity, as above, when the form & service are re-deployed on the portal after payment of applicable fees. Stakeholders may kindly note and plan accordingly.

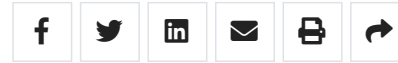
