Registration open for Articleship exam to be held in December

The next practical training assessments are being scheduled on December 8 and 29, 2019. The students who have completed their 1st/ 2nd year of practical training during January 1 – September 30, 2019 are eligible to appear in these tests.

The students who have already appeared in the Practical training tests before (one or two times) and wish to improve their performance/ grade can re-appear in any of these tests. In such case, the best of the grade will be considered for inclusion in the marksheet. Similarly, the students who have registered for the earlier test(s) but could not appear due to some reason, can also register for any of these two tests with a fee of Rs.200. **The registration for these test dates will open on October 15, 2019 (Tuesday) at 12.00 noon and close on October 21, 2019 (Monday).**

Students may register for the test during the above mentioned time period through the registration portal <https://pttest.icai.org/> by selecting their preferences for test date and location. Students who wish to reappear may also register by submitting a fee of Rs.200 online. Selecting a test location will not imply confirmation for that location. Student may be assigned any location out of the two selected locations depending on the number of candidates in that region for that test date. However, preference will be given to the location selected as the first preference.

For the students who would wish to re-appear in December 29, 2019 test after the declaration of result of December 8, 2019 test, the registrations will be opened again in December, 2019. The date of registrations will be announced on the Institute website through Board of Studies Announcements.

For any issues/ queries related to registration, students may contact the Help Desk mentioned on the portal. Students are advised to register for the tests well in time to avoid last minute hassles. 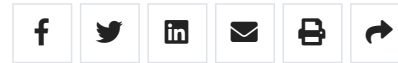
