The opposition party took to Twitter and expressed serious concerns on the structural issues in GST, the tweet from the party's official handle read, "An ill-conceived GST, serious structural issues & a govt that is determined to defend unto death their own ineptitude - the unfortunate recipe that has landed the Indian economy in the trouble it's in."

The post shared on twitter also claimed that the flawed implementation of GST had led to a loss of over Rs 5 trillion which is equivalent to 2.5% of the country's GDP and about 40% of the total GST Revenue Collection. What are your views, do you think that the implementation of GST was flawed?
